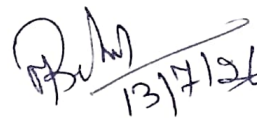

The Contractor/Firm should have valid registration from State PWD or any other Government department or from CPWD. The contractors having previous work experience minimum two years in similar nature of work will be eligible to apply for enlistment. The Contractors/Firms shall submit the following documents along with their Pre-Qualification Bid.

1. PAN and valid ITCC from income tax department for all ranges.
2. GST registration and valid GST clearance certificate for all ranges.
3. Credential / Past experience of the firms
4. Valid Contractor License.

VALIDITY OF ENLISTMENT:-

The enlistment is valid for a period of One year from the date of issue of the letter of initial registration.

GENERAL

- a) The pre-qualification does not guarantee for award of any work as such. The enlisted Contractors will be eligible for participate the tender for a particular work within the jurisdiction of Cuttack Division, OSPHWC.
