The Contractors / Firms shall submit the following documents along with their Pre-Qualification Document.

- 1. PAN and valid ITCC from income tax department for all ranges.
- 2. Valid GST Certificate.
- 3. Credential / Past Experience of the firms.
- 4. Valid Contractor License.
- 5. Previous work Experience Certificates.

#### VALIDITY OF ENLISTMENT: -

The enlistment is valid for a period of One year from the date of issue of the letter of initial registration.
