The contractors having previous work experience minimum two years in similar nature of work will be eligible to apply for enlistment. The Contractors / Firms shall submit the following documents along with their Pre-Qualification Document.

1. PAN and valid ITCC from income tax department for all ranges.
2. Valid GST Certificate.
3. Credential / Past Experience of the firms.
4. Valid Contractor License.
5. Previous work Experience Certificates.

VALIDITY OF ENLISTMENT: -

The enlistment is **valid for a period of One year from the date of issue of the letter of initial registration.**

GENERAL

- a) **The pre-qualification does not guarantee for award of any work as such.**
