The Contractors/Firms shall submit the following documents along with their Pre-Qualification Document.

1. PAN and valid ITCC from income tax department for all ranges.
2. GST registration and Valid GST clearance certificate for all ranges.
3. Up- to date Return of GSTR-3B & GSTR-1 up to September-2024.
4. Credential / Past experience of the firms
5. Valid Contractor License.
6. MOU for Electrical work.

VALIDITY OF ENLISTMENT:-
